

## **Regulations for Visitors**

### **3<sup>rd</sup> International Eco Fleet Fair EkoFlota: Innovation, Ecology, Mobility - Warsaw 2018**

#### **GENERAL PROVISIONS:**

1. These Regulations shall apply to Visitors of 3rd International Eco Fleet Fair EkoFlota: Innovation, Ecology, Mobility - Warsaw 2018, hereinafter referred to as the "EkoFlota Fair", which is organized by Menadżer Floty Sp. o.o. ("Organizer") with its registered office in Wrocław (50-559), 51-57 Świeradowska St., entered into the Register of Entrepreneurs of the National Court Register (KRS), under KRS number 0000423164, Tax Identification Number NIP 899-273-61-44. These Regulations shall also apply to Visitors of events co-organized along with the EkoFlota Fair.
2. The Regulations define the rules for the provision of services for Visitors, in particular the conditions of entry and order regulations that apply to Visitors of the Fair and other events organized in the area belonging to the Fair premises or elsewhere, hereinafter also referred to as the "Event Site".
3. Entry to the Event Site during the Fair and other events constitutes acceptance of these Regulations for Visitors, as well as a commitment to comply with their provisions.
4. Admission to the site of the Fair is subject to regulation. On the days 15-16 June 2018 it is possible only based on an admission document and is subject to control. Detailed rules for entry to the EkoFlota Fair and other events are determined by the Organizer of the Fair and events, and announced on the website of the Fair, as well as at in Visitor Services Points at the Event Site.
5. Prior registration is a prerequisite for attending the Fair on 15 June 2018. Only Professional Visitors representing industries related to the theme of the Fair shall be entitled to register.

#### **ORDER REGULATIONS:**

1. Visitors may stay at the premises of the Fair, only on the date and time of opening of the Fair.
2. At the premises of the Fair it is prohibited:
  - Conducting by the Visitor any commercial activities, canvassing, soliciting, advertising, promoting, campaigning and fundraising which is not agreed upon with the Organizer, as well as actions contrary to the applicable law;
  - Bringing in and use of weapons, ammunition, pyrotechnic materials and harmful chemicals, as well as open flame, posing a risk of fire, property damage and posing a danger to health and life;
  - Bringing in and consumption of alcohol and distribution and consumption of narcotics;

- Disturbing public order;
- Bringing in animals, as well as bicycles, skateboards, etc.;
- Smoking tobacco products with the exception of dedicated and specially marked areas;
- Polluting pavilions and open areas with waste generated by Visitors themselves (beverage and food packaging, cigarette butts, chewing gum, etc.).
- Destroying infrastructure.

3. Persons being in a state of considerable alcohol or drug intoxication, or trying to bring in alcohol, drugs or dangerous objects shall not be allowed into the premises of the Fair.

In the event of non-compliance with the above-mentioned prohibitions, the Organizer reserves the right to immediately take the Visitor out of the premises of the Fair and prevent re-entry, and in justified cases, call for the Police.

#### **VISITORS ARE REQUIRED TO:**

1. Respect the signed zones separated from traffic which are subject to fire protection;
2. Follow order commands given by the services of the Organizer due to organizational reasons or for the need to protect property and ensure safety of persons present at the Fair;
3. Comply with road traffic regulations in force in the road traffic area within the premises of the Fair.

#### **LIABILITY:**

1. The Organizer shall reserve the right to cancel, shorten or postpone the Fair and undertakes to inform thereof sufficiently in advance on the websites of the Fair.
2. The Organizer shall not be held liable for personal injuries inflicted to Visitors caused by third parties or due to the fault of the victim. The Organizer shall not be held liable for any damage to property of Visitors caused by force majeure (e.g. fire, explosion, lightning strike, high winds, flooding) or by third parties or due to the fault of the victim.
3. Security measures taken at the event (technical protection, security services, monitoring) shall not affect the exclusion of the Organizer's liability due to the above-mentioned reasons.
4. Visitors are obliged to protect their belongings and property brought into the Event Site against possible damage or loss at their own risk and expense (e.g. keys, documents, luggage, laptops, cameras, mobile phones).
5. Visitors shall be held liable for causing damage and inflicting losses at the Event Site.

#### **FINAL PROVISIONS:**

1. The Organizer undertakes to inform of any changes to the Regulations and announce with reasonable notice their uniform text on the website of the Fair.
2. To matters not regulated by the Regulations the applicable law shall apply, in particular the Civil Code.
3. The Organizer reserves the right to record the course of the Fair (using video and / or sound registering equipment). Therefore, pursuant to art. 81 of the Act of 4 February 1994 On Copyright And Neighbouring Rights, persons present at the premises of the Fair, by the fact of attending the Fair, give their consent, without additional remuneration, to capture, usage and dissemination of their image constituting a detail of a whole, for purposes of documentation, promotion and education, with no time and territorial limits in advertising materials of the Organizer, in particular outdoor advertising, newspaper advertisements, the Internet, as well as to produce and present photographic, video and audio materials and coverage of the Fair and / or any part of the event in the media worldwide. At the same time, each attendee may reserve the right to refuse granting such consent to the Fair Organizer.
